

## DEPARTMENT OF CORRECTIONS 2021 Prison Rape Elimination Act (PREA) Corrective Action Plan and Annual Report

The Florida Department of Corrections (FDC) has adopted a zero-tolerance policy regarding sexual abuse and sexual harassment. The Department is continuously improving operations to prevent, detect, and respond to sexual victimization. This annual report complies with 28 C.F.R. Part 115 Standard 115.87-89 for the agency.

In June 2021, the FDC completed year two in cycle three of the Department of Justice Prison Rape Elimination Act (PREA) audit cycle and accomplished the third year of full compliance for all facilities audited. Some of the audited facilities were identified as having exceeded requirements in the final audit report.

During the 2021 calendar year, FDC had 1,550 allegations meeting the definitions in standard 115.6 related to sexual abuse of the Prison Rape Elimination Act. These allegations were reported statewide and encompass 50 institutions, including their satellite facilities, seven privately operated facilities, and individuals under FDC supervision as a condition of their probation. All allegations were reported to the Office of the Inspector General (OIG). Below is a comparison table detailing the PREA allegations for the 2020 and 2021 calendar years. Currently, there are zero sustained cases for 2021.

The culture within the Florida Department of Corrections is changing. With the implementation and continuous improvement of its sexual abuse prevention, detection, and response in 2021, there was a decrease of 193 allegations from 2020. The Department has continued its training efforts for staff and inmates, making them aware of what constitutes a PREA allegation under the definitions provided in 28 C.F.R. Part 115. Additionally, the staff has continued to be diligent in reporting and documentation practices of allegations.

In comparison to the previous year's corrective action plan, in 2021, the Department added the PREA "What You Need to Know" video on the inmate tablets and continued to build on its efforts to improve current reporting policies and procedures. The installation of additional video monitoring technology and physical plant modifications made at facilities throughout the year have continued to enhance safety and security.

In 2021, the Department continued its efforts to improve our critical staffing shortages by seeking approval through the Legislative Budget Commission (LBC) to increase the base rate salary for several positions in the Correctional Officer class series, specifically Correctional Officer through Correctional Officer Captain. The LBC approved our request, and the increase was effective December 24, 2021. In addition to the base rate of pay increase, staff in this class also received a one-time retention bonus of \$1,500. A one-time retention bonus of \$3,000 for staff in the Correctional Probation class series was also implemented. The Department also increased the New Hire Bonus Program for Correctional Officers to aid our recruitment and retention efforts. The program includes the following bonus structure:

- \$3,000 hiring Bonus for all Correctional Officers (certified or non-certified)
- \$1,000 hiring bonus for correctional officers to join facilities with a vacancy rate of 10% or above (certified or non-certified)
- \$1,000 hiring bonus for certified correctional officers

  Certified staff returning are eligible to receive \$5,000 if all the above criteria are met.

The state budget for FY 22/23 approved by the Florida Legislature contains an across-the-board pay raise for all staff and a substantial pay increase for the Correctional Officer and Correctional Probation Officer series. It is currently awaiting Executive Branch approval and a July 1 implementation.

The Department plans to build and improve on the below corrective actions over the next year from the foundation that has been set in years past.

- Continue our efforts to recruit and retain employees to fully staff facilities.
- Continue to provide advanced training to PREA Compliance Managers and PREA Auxiliary staff on PREA definitions, reportable incidents, and PREA compliance, allowing them to conduct needed training for the facility staff.
- Continue to provide training to inmates on PREA definitions and reporting requirements.
- Continue to utilize available funding for installing cameras in common areas, program areas, work areas, and high traffic areas.

The Department intends to initiate the below projects and to continue our efforts to recruit and retain staff and additional positions for the Office of the Inspector General (OIG) over the next year:

- Review and make any necessary revisions to the Department's current Volunteer, Contractor, and Intern training
- Review the options for placement of PREA related resources on the inmate tablets
- Through Legislative action, persue competitive pay increases for all series with direct inmate offender contact.
   These include the Correctional Officer class, Correctional Probation Officers, Classification, and Maintenance.
- Through Legislative action, persue competitive pay increases for OIG Inspectors and increase the number of Inspectors dedicated to PREA investigations.

Our corrective action plan outlined above serves to reduce victimization by deterring abusive behavior and dealing with it appropriately and justly when it does occur. These measures will subsequently reduce reported allegations over time and foster a safe environment.
