
Your Affiant is Inspector Scott Gambel with the Office of Inspector General for the Florida Department of Corrections, and the defendant is Inmate Thomas M. Smith who was assigned to Hamilton Correctional Institution Work Camp. Your affiant has conducted an investigation into a Trafficking in Methamphetamine.

On October 07, 2019, Officer Richard Soules reports that while assigned as a work squad officer at the Lake City Department of Transportation, he was monitoring his assigned inmates when they requested a restroom break. Officer Soules conducted pat searches of each inmate as they exited the restroom when he observed Inmate Smith with a brown paper bag balled up in his hand. Officer Soules ordered Inmate Smith to relinquish the bag in which he did. Officer Soules discovered that the paper bag contained 2 bundles wrapped in black electrical tape. Inmate Smith was placed in hand restraints and returned to the institution. Officer Soules did not open the bundles until his return to the institution, and when he did, found they contained 26.9 grams of suspected Methamphetamine, 35 pills, and 15.1 grams of synthetic cannabinoids (K-2). The suspected Methamphetamine was submitted to the Florida Department of Law Enforcement (FDLE) lab where it tested positive for Methamphetamine. The pills were identified by the markings on the outside as Subutex, a generic form of Suboxone. All recovered substances are held in the Office of Inspector General's Regional Evidence Control Area.

In a post Miranda interview, Inmate Smith admitted [REDACTED]

Your Affiant respectfully submits probable cause has been established that Inmate Thomas Smith did commit the violation of Trafficking in Methamphetamine in violation of FSS 893.135 (f)1a and one count FSS 893.13(1)(a) Possession of a Controlled Substance (*Suboxone*) in Columbia County on October 07, 2019. Your Affiant respectfully requests a warrant be issued for Inmate Thomas Smith for one count of FSS 893.135 (f)1a, Trafficking in Methamphetamine, and FSS 893.13(1)(a) one count Possession of a controlled substance (*Suboxone*).

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your affiant's report of investigation.
