_____ arrived at the dormitory and observed other officers attempting to restrain Inmate Gooden. _____ stated _____ After Inmate Gooden was placed in hand restraints, _____ and Officer James escorted Inmate Gooden to the _____ per department policy.

_____ stated Inmate Gooden continued with his verbal assaults until arriving at the _____. Once in the lobby, Captain Robert Brooks began talking to the inmate attempting to calm him down. Captain Brooks stated Inmate Gooden was physically resistant to being seated and eventually broke free from Officer James' grasp which caused _____ to fall to the ground with Inmate Gooden.

As Inmate Gooden was being helped up, he once again tried to break free of his hold by the officers and spit on the left side of _____ face. _____ and Officer James then pushed Inmate Gooden up against a wall to prevent him from spitting again, while giving him verbal orders not to do so again and to stop resisting.

Inmate Gooden was then taken into a _____ where Officer _____ began a hand-held recording of the _____. Inmate Gooden was then escorted to a confinement cell. Inmate Gooden continued to resist officers and refused to allow officers to remove his hand restraints once inside of the cell. Inmate Gooden can be seen on video manipulating his handcuffs from behind his back to his front. Shortly after, Inmate Gooden stated to _____ "do you want to see something?", at which point he exposed himself to _____ and began masturbating his penis with his right hand.
