Your affiant is Law Enforcement Senior Inspector E. J. Whatley of the Office of the Inspector General, Florida Department of Corrections.

Your Affiant has probable cause to believe that on or about March 19, 2019, while at the Lawtey Correctional Institution, in Bradford County Florida, Inmate Gabriel Lopez #J10624 did commit the offense of Introduction, Removal or Possession of Contraband in a correctional Institution; in violation of § 944.41(1)(a)(c) and Trafficking in Phenethylamines; in violation of § 893.135(1)(k)1a; when a tan substance which tested positive for Eutylone (3,4-Methylendioxy-alpha-ethylaminobutyrophenone), weighing 69.12 ±0.14 grams, was found concealed between the sheet and mattress of the bunk belonging to Inmate Lopez.

Captain Andrew Johnson, a certified, uniformed Correctional Officer, reported that on March 19, 2019, while assigned to the office of intelligence, where he operated a narcotic certified K9, at Lawtey Correctional Institution. Lawtey, Florida, conducting a K9 search of the compound. While searching B-Dormitory at Lawtey Correctional Institution, his narcotic certified K9, alerted to the odor of narcotics coming from bunk 108L, which was which is the assigned bunk belonging to Inmate Gabriel Lopez DC #J10624. When Captain Johnson pealed back the sheets, between the sheets and the mattress, there was a plastic bag containing a tannish color powder substance, weighing approximately 69.3 grams. He tested the substance and it yielded a positive result for methamphetamine. Inmate Lopez committed the criminal offense of Introduction, Removal or Possession of Contraband in a correctional Institution; in violation of § 944.41(1)(a)(c) and Trafficking in Phenethylamines; in violation of § 893.135(1)(k)1a Florida State Statute.

Captain Adrian Tucker, a certified, uniformed Correctional Officer, reported on March 19, 2019, while assigned to the office of intelligence, he was at Lawtey Correctional Institution, Lawtey, Florida, conducting K9 search of Lawtey Correctional Institution, with Captain Andrew Johnson and Sergeant Hillary Watson the STG (Security Threat Group) sergeant. He did not witness Captain Johnson discover the contraband, he was at a different location at the time. He was present during the testing of the contraband, it tested positive for meth (methamphetamine).

Sergeant Hillary Watson, a certified, uniformed Correctional Officer, reported on March 19, 2019, while assigned as the security threats group coordinator and Lawtey Correctional Institution, Lawtey, Florida, remembers being in B-Dormitory while Captain Johnson and Captain Tucker conducted K-9 searches of the dormitory. Sergeant Watson was not present during the time the substance was found, however Captain Johnson showed the Sergeant Watson indicated Inmate Lopez was asked what the substance was, the inmate said it was Crystal Lite (Powder drink mix) and admitted the substance was his.

A post Miranda recorded interview was taken from Inmate Gabriel Lopez. In his statement Inmate Lopez advised the substance found belonged to him, but the substance was a work out substance called Factor9. Inmate Lopez admitted to telling the officers it was kool-aid, because it tasted like lemonade. Inmate Lopez admitted the substance was under the cover on his mattress.

On November 21, 2019, a report was received from Crime Laboratory Analyst Kayla Kahre, with the Jacksonville Regional Operations Center of the Florida Department of Law Enforcement. The report described the substance tested was Eutylone (3,4-Methylenedioxy-alpha-ethylaminobutyrophenone), weighing 69.12 ±0.14 grams.

Your affiant respectfully submits that based on the recorded statements provided by Captain Johnson, Captain Tucker, Sergeant Watson, Crime Laboratory Analyst Kahre and Inmate Lopez probable cause has been established that Inmate Gabriel Lopez #J10624 committed the crime of Introduction, Removal or Possession of Contraband in a correctional Institution; in violation of § 944.41(1)(a)(c) and Trafficking in Phenethylamines; in violation of § 893.135(1)(k)1a as defined in Florida State Statute 784.07(2)(b).
