Your Affiant is Inspector James Padgett with the Office of the Inspector General - DC.

Your Affiant has probable cause to believe that on October 05, 2019, Officer John D. Schrader, while on duty at Wakulla Correctional Institution Annex (WCLA), did committ the criminal offense of; Malicious Battery on Inmate [redacted] DC# [redacted] when, Officer Schrader slapped Inmate [redacted] utilizing an open hand, striking him in his head while on the Close Management Recreation Yard of WCIA without justifiable cause to use force under Florida Statute §944.35(1)(a). Officer Schrader [redacted]



While assisting with the feeding of the noon meal, Officer Schrader gave Inmate [redacted] an order to not "push" any extra food trays to the inmates on the recreation yard and then struck Inmate [redacted] in the back of his head stating to Inmate [redacted] "use your fucking head dumb ass."

After the battery occurred, Officer Schrader self-reported striking Inmate [redacted] to his direct Supervisor, Sergeant Jason Horton, who took immediate action by notifying his chain of command.

Officer Mathew Webster was present on the recreation yard and provided sworn testimony that he witnessed Officer Schrader strike Inmate [redacted] in the head with an open hand. Officer Webster was later told by Sergeant Jason Horton that Officer Schrader self-reported his actions of striking Inmate [redacted]

Sergeant Jason Horton provided sworn testimony that Officer Schrader approached him on October 05, 2019 and reported that he "popped" Inmate [redacted] in his head. Sergeant Horton then spoke with Inmate [redacted] who confirmed Officer Schrader had indeed struck him in the head with an open hand.

Your affiant respectfully submits, probable cause has been established in that, Officer John David Schrader did commit the criminal violation of; Malicious Battery of an Inmate, in violation of §944.35(3)(a)1, at Wakulla Correctional Institution Annex in Crawfordville, Florida.
