Your Affiant is Inspector Chris McGauley with the Office of Inspector General for the Florida Department of Corrections.

On November 7, 2020, I was contacted by Supervisor Johnny Webb (Supervisor Webb) in reference to allegations of a visitor in possession of contraband at Mayo Correctional Institution (MCI). Upon my arrival, I was briefed of the situation by Captain Jim Godwin (Captain Godwin) with the Florida Department of Corrections K-9 Team. Captain Godwin conducted a free air sniff (with K-9 Rowdy) around the perimeter of the car Visitor Amanda Finch (Finch) drove onto state property to visit Inmate Joshua Lawrence (Inmate Lawrence) DC# P31645. K-9 Rowdy alerted to the vehicle for the presence of possible narcotics inside of it. After gaining consent to search from Finch, Captain Godwin located a marijuana roach (brown cigarette that contained marijuana), marijuana grinder and a small blue package of marijuana and two small pills in the rear of the vehicle. Captain Tyler Brown located a small baggy of white crystal substance in the change purse on the driver seat inside the car. Finch freely admitted to Captain Godwin (before the search started) that the marijuana was in the rear of the vehicle and in a pack of cigarettes.

This inspector conducted a sworn recorded interview of Finch, post Miranda and noted the following: She indicated that she came from south Florida and didn't realize the contraband was inside the change purse but did claim ownership of the purse. She came to visit Immate Lawrence and indicated that he had no knowledge of her visit today and didn't request her to bring the contraband. She was the only person that had access to the inside of the vehicle, and no one came with her to MCI. She indicated that she knew what the contraband was, and she was a frequent user of it.

The white powdery substance was field tested by Captain Brown, witnessed by this inspector, and tested positive for methamphetamines. The evidence weighed approximately 1.1 grams after testing was completed. The methamphetamine was packaged, submitted for evidence in the TSL (*Temporary Storage Locker*) at MCI.

Your Affiant respectfully submits probable cause has been established Amanda Finch did commit the violation of one (1) count of Possession of a Controlled Substance in violation of \$ 893.13 in Lafayette County, Florida, Mayo Correctional Institution on November 7, 2020

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your affiant's report of investigation.
