84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the heretofore named defendant did commit the violations of law as stated above and the factual basis for this belief is as follows:

Your affiant, Inspector Greg Fulcher, is a sworn law enforcement officer, for the Office of Inspector General, Florida Department of Corrections.

On November 3, 2020, at Desoto Correctional Institution Annex, Arcadia, Florida, Desoto County, the above named defendant, Inmate Rodney Coston born 08/13/1965, did violate Florida State Statutes, committing the criminal offenses of: Battery of a Law Enforcement Officer; by knowingly and intentionally without consent; physically struck another namely uniformed Correctional Officer [REDACTED] (1 Count) (F.S.S. 784.07 (1)(d)), and Resisting officer with violence (1 count) (F.S.S. 843.01). The defendant, Coston, struck Officer [REDACTED] in the head with a fist [REDACTED] to Officer [REDACTED] person. Officer [REDACTED] was in full uniform consisting of a gray shirt with a badge and arm insignias and black uniform utility pants. This occurred at Desoto Correctional Institution Annex (C.I.), where Coston was an incarcerated inmate.

Contact was made with the victim, Correctional Officer [REDACTED] Officer [REDACTED] was [REDACTED] Officer [REDACTED] stated he wished to pursue criminal charges.

Witness, Correctional Sergeant Andrew Jimenez, provided a sworn statement regarding the incident involving Officer [REDACTED] and Inmate Coston. Jimenez was assigned as the outside grounds sergeant at the institution and was conducting meal service. He was on the walkway outside the cafeteria and was looking towards a group of inmates preparing to walk to the cafeteria. He observed Officer [REDACTED] instruct and direct inmates to line up to proceed to the cafeteria. He observed Inmate Rodney Coston, continually refuse to comply with the officer's orders and then resist the officer's attempt to take him into custody. Jimenez observed Coston punch Officer [REDACTED] in the head. Jimenez responded to assist and observed [REDACTED] on Officer [REDACTED]

Offender, Coston declined to provide a statement and made no comment in reference the offense.

In summary, the defendant, Rodney Coston, did knowingly and intentionally subject uniformed Correctional Officer [REDACTED] to physical contact while physically resisting being taken into custody. Coston struck Officer [REDACTED] in the head, [REDACTED] at Desoto Correctional Institution, violating 1 count of Florida State Statute 784.07 (1)(d): Assault or battery of law enforcement officer; and violation 1 count of Florida State Statute 843.1: Resisting officer with violence to his or her person.
