The Undersigned Certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following Violation of the law:  
On the 27<sup>th</sup> day of January 2024, at 2:00  AM.  PM (Specially include facts constituting cause for arrest)

Your Affiant is Senior Inspector Detective Scott Gambel (*ID Gambel*) with the Office of Inspector General for the Florida Department of Corrections. The Defendant is Sharubia Ervin (*Ervin*), who was a visitor to Mayo Correctional Institution (*MCI*). Your Affiant has conducted an investigation into an Introduction of Contraband.



On January 27, 2024, Sharubia Ervin, a visitor to MCI, was found to be in possession of contraband during a pat search by Correctional Officer April Colwell (*Officer Colwell*). During the pat search, Officer Colwell located an object in the crotch area of Ervin. Ervin then produced two bundles of an unknown substance wrapped in electrical tape. Ervin told Officer Colwell she did not know what the bundles contained. Officer Colwell turned the bundles over to Captain Colin Woodle (*Captain Woodle*). ID Gambel arrived on scene and questioned Ervin post Miranda. Ervin [REDACTED]

[REDACTED] Inmate Pearson was questioned post Miranda and stated he did not know who Ervin was and did not admit to the conspiracy to introduce the contraband.

Captain Woodle opened and tested the bundles with ID Gambel present. One contained 23 grams of cannabis and the other contained 116 grams of Methamphetamine. Ervin was arrested by ID Gambel and transported to the Lafayette County Jail by the Lafayette County Sheriff's Office.

Your Affiant respectfully submits probable cause has been established indicating Sharubia Ervin did commit the violation of Introduction of Contraband in violation of FSS 944.47(1)(a) in Lafayette County, Mayo Correctional Institution Annex on January 27, 2024.

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your Affiant's report of investigation.
