84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the heretofore named defendant did commit the violations of law as stated above and the factual basis for this belief is as follows:

Your Affiant is Detective Steven Lee (Det. Lee) of the Florida Department of Corrections, Office of the Inspector General.

Your Affiant has probable cause to believe Inmate Duan Freeman DC# G10439 (Inmate Freeman) an inmate in the Florida Department of Corrections, did commit the criminal offense of Attempted Sexual Battery, False Imprisonment, and Felony Battery, while housed at Northwest Florida Reception Center (NWFRC), a state prison operated by the Florida Department of Corrections in Washington County, Florida.

On February 28, 2024, Inmate Freeman was [REDACTED] stated in her sworn recorded interview, [REDACTED]



Upon Inmate Freeman hearing staff approaching, he got off [REDACTED] and was found sitting in a chair. Arriving staff restrained Inmate Freeman and placed him in a confinement unit pending charges.

Det. Lee collected photographs of [REDACTED] was [REDACTED] at NWFRC [REDACTED]

According to the information provided by [REDACTED] and confirmed by photos, Inmate Freeman forcibly restrained [REDACTED] when he grabbed her without lawful authority and against her will. Inmate Freeman the pushed [REDACTED] approximately 30 feet backwards, attempting to secretly confine her while he could attempt to sexually abuse her. Inmate Freeman was able to push [REDACTED] down behind a desk further limiting her ability to escape. Inmate Freeman only stopped his attempted sexual assault, once responding staff members arrived.

Your Affiant respectfully submits that probable cause has been established that Inmate Duan Freeman did commit the criminal violations of Attempted Sexual Battery FSS 794.011(3)(b), False Imprisonment FSS 787.02(1)(a), Felony Battery FSS 784.03(1)(a)(2) by forcibly grabbing and pushing [REDACTED] into a back office where she struck her head against the concrete floor as Inmate Freeman straddled her waist in an attempt to sexually assault her while he was housed at Northwest Florida Reception Center


