84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the heretofore named defendant did commit the violations of law as stated above and the factual basis for this belief is as follows:

Your Affiant is Law Enforcement Inspector James K. Maloney, of the Office of the Inspector General, Florida Department of Corrections.

Your Affiant has probable cause to believe and does believe that on January 19, 2021, Inmate Tijuan Isaac, DC #V42164, did commit the Offense of Attempted Murder (on a Correctional Officer) in violation of F.S.S. 782.04(2).

Based on sworn, recorded statements, from the victim, Correctional Officer [REDACTED] and physical evidence, FLDOC-IG Case 21-00988 was initiated.

In sworn testimony, obtained on January 19, 2021, Officer [REDACTED] (*victim*) indicated [REDACTED]

In sworn testimony, obtained on January 19, 2021, Captain Johnathan Jones (witness) indicated he was working at the Santa Rosa Correctional Institution, on January 19, 2021, when he responded to G-Dormitory, about a battery on staff. Captain Jones arrived at G-Dormitory, Wing-2, and observed Inmate Isaac walking around the interior of the dormitory, unsecured. Captain Jones observed a homemade weapon in Inmate Isaac's hand and ordered Inmate Isaac to return to his assigned cell. Inmate Isaac returned to his cell, but prior to entering the cell, Inmate Isaac threw a white homemade weapon, with a blue handle, onto the floor of G-Dormitory, Wing-2. Captain Jones confirmed Inmate Isaac returned to his cell and then retrieved the homemade weapon.

In sworn testimony, obtained on January 19, 2021, Officer John Cahn (witness) indicated he was working at the Santa Rosa Correctional Institution, on January 19, 2021, when he responded to G-Dormitory, about a battery on staff. Officer Cahn arrived at Wing-2 and observed Inmate Isaac walking around the interior of the dormitory, unsecured. Officer Cahn observed a homemade weapon in Inmate Isaac's hand and as Inmate Isaac entered cell 2122, he threw the weapon on the floor. Officer Cahn observed Captain Jones retrieve the weapon.

- 17:47:00 Video starts
- 17:47:24 Officer [REDACTED] enters camera view and walks to cell 2121.
- 17:48:15 Inmate Isaac exits cell 2122 and charges at Officer [REDACTED]
- 17:48:17 Inmate Isaac's right arm extends towards Officer [REDACTED]
- 17:48:20 Inmate Isaac is heard saying, "come here" as he is chasing Officer [REDACTED]
- 17:48:28 Officer [REDACTED] exits through the security gate to Wing-2 and secures the gate.


A photograph of the weapon was obtained and is described as a homemade metal weapon, sharpened to a point at one end, with a piece of blue cloth wrapped around the other end as a handle. The weapon is the one used by Inmate Isaac to [REDACTED] Officer [REDACTED]

On January 19, 2021, Inmate Tijuan Isaac (*suspect*) refused to provide a post-Miranda statement and signed an Interview Refusal Form.


