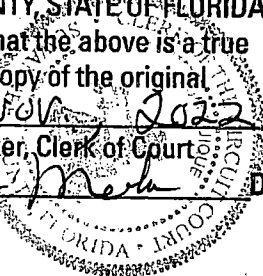



Your Affiant is Senior Inspector Scott Gambel with the Office of Inspector General for the Florida Department of Corrections. The Defendant is Inmate Shauntwan Barnes, DC# N21938 (Inmate Barnes) who was assigned to Suwannee Correctional Institution (SWC). Your Affiant has conducted an investigation into a Battery on a Law Enforcement Officer.					
On October 29, 2022, [REDACTED] reported that Inmate Barnes grabbed his hand through the cell door food flap pulling [REDACTED] hand inside the door along with Correctional Officer Sergeant Gregory Tucker (Sergeant Tucker) and Correctional Officer Christopher Richards (Officer Richards) were placing Inmate Barnes back into his assigned cell after [REDACTED]. According to [REDACTED] Inmate Barnes was angry and uncooperative [REDACTED]. As [REDACTED] was removing the hand restraints from Inmate Barnes through the cell door cuffing port, Inmate Barnes grabbed [REDACTED] by the hand, pulling his hand inside the cell door port, [REDACTED].					
Fixed wing video shows [REDACTED] at the cell door reaching for the hand restraints at the cell door. [REDACTED] can be seen struggling with Inmate Barnes to get his arm out of the cell door port.					
Your Affiant respectfully submits probable cause has been established indicating Inmate Barnes did commit the violation of Battery on a Law Enforcement Officer in violation of Florida State Statute 784.07(2)(b) in Suwannee County, Suwannee Correctional Institution on October 29, 2022.					
Your Affiant respectfully requests a warrant be issued for Inmate Barnes for one count of Florida State Statute 784.07(2)(b), Battery on a Law Enforcement Officer.
