HB 95 - Relating to Rights of Law Enforcement Officers and Correctional Officers

Ch. 2023-230 Laws of Florida

Approved by the Governor on June 13, 2023



Effective Date: July 1, 2023

The bill amends statutory language by:

- Providing rights of law enforcement officers & correctional officers relating to Brady identification systems;
- Providing that prosecuting agency is not required to maintain such system;
- Providing requirements for employing agency of officer;
- Providing requirements for prosecuting agency including minimum written policies,
- Removing officer's name under certain circumstances, & providing certain notice;
- Authorizes officer to request reconsideration of inclusion of his or her name & information in such system;
- Authorizing officer to petition for writ of mandamus.

Authorizing specified persons to visit county & municipal detention facilities.

HB 139 - Relating to Benefits, Training, and Employment for Veterans and Their Spouses

Ch. 2023-161 Laws of Florida

Approved by the Governor on May 26, 2023

- Requiring analysis of VETS Program;
- Revising duties of the Department of Veteran Affairs (DVA) & Florida Is For Veterans, Inc., to include assistance to veterans' spouses;
- Revising purpose & duties of VETS Program to include assistance to veterans' spouses;
- Requiring Florida Is For Veterans, Inc., to assist veterans or their spouses in accessing employment & licensure in health care professions;
- Requiring the Department of Health (DOH) to waive certain fees for veterans & their spouses;



- Requiring appropriate board or DOH to expedite health care licensure applications submitted by veterans;
- Establishing Office of Veteran Licensure Services; provides appropriations & authorizes positions.

SB 162 - Relating to Water and Wastewater Facility Operators Ch. 2023-204 Laws of Florida Approved by the Governor on June 9, 2023

The bill amends statutory language by:

- Revising legislative findings and intent; requiring the Department of Environmental Protection (DEP) to issue water treatment plant operator licenses, water distribution system operator licenses, and domestic wastewater treatment plant operator licenses by reciprocity to certain applicants;
- Providing licensure requirements;
- Authorizing the department to issue temporary operator licenses during a declared state of emergency, etc.



SB 210 - Relating to Substance Abuse Services

Approved by the Governor on June 27, 2023

The bill amends statutory language by:

- Revising application requirements for licensure as a substance abuse service provider;
- Requiring the Department of Children and Families (DCF) to establish, by a specified date, a mechanism to impose and collect fines for certain violations of law;
- Revising credentialing requirements for recovery residences;
- Prohibiting service providers from referring patients to, or accepting referrals from, specified recovery residences, etc.

SB 242 - Relating to Fiscal Accountability
Ch. 2023-214 Laws of Florida
Approved by the Governor on June 12, 2023

The bill amends statutory language by:

- Requiring state entities to post any documents submitted on the contract tracking system which indicate the use of state funds as remuneration under certain contracts, beginning on a specified date;
- Deleting a provision requiring state entities to publish payments on the contract tracking system;
- Requiring that contracts for services executed, amended, or extended beginning on a specified date require contractors to provide specified documentation to be included in the contract tracking system and posted to the contractor's website, if applicable, etc.

SB 254 - Relating to Treatments for Sex Reassignment Ch. 2023-90 Laws of Florida Approved by the Governor on May 17, 2023

The bill amends statutory language by:

 Granting courts of this state temporary emergency jurisdiction over a child present in this state if the child has been subjected to or is threatened with being subjected to sexreassignment prescriptions or procedures;



Effective Date: May 17, 2023

Effective Date: July 1, 2023

- Providing that, for purposes of warrants to take physical custody of a child in certain child custody enforcement proceedings, serious physical harm to the child includes, but is not limited to, being subjected to sex-reassignment prescriptions or procedures;
- Prohibiting certain public entities from expending state funds for the provision of sexreassignment prescriptions or procedures;
- Prohibiting sex-reassignment prescriptions and procedures for patients younger than 18 years of age;
- Requiring the department to immediately suspend the license of a health care practitioner
 who is arrested for committing or attempting, soliciting, or conspiring to commit specified
 violations related to sex-reassignment prescriptions or procedures for a patient younger
 than 18 years of age, etc.

SB 258 - Relating to Prohibited Applications on Government-issued Devices Ch. 2023-32 Laws of Florida Approved by the Governor on May 8, 2023

The bill amends statutory language by:

- Requiring public employers to take certain actions relating to prohibited applications;
- Prohibiting employees and officers of public employers from downloading or accessing prohibited applications on government-issued devices;
- Providing exceptions;
- Providing a deadline by which specified employees must remove, delete, or uninstall a prohibited application;
- Requiring the Department of Management Services (DMS) to compile a specified list and establish procedures for a specified waiver, etc.

SB 262 - Relating to Technology Transparency
Ch. 2023-201 Laws of Florida

Approved by the Governor on June 6, 2023

The bill amends statutory language by:

 Prohibiting officers or salaried employees of governmental entities from using their positions or state resources to make certain requests of social media platforms;

- Designating the "Florida Digital Bill of Rights";
- Providing that a consumer may submit requests to controllers to exercise specified rights;
- Requiring controllers to limit the collection of personal data according to certain parameters;

- Preempting the collection, processing, sharing, and sale of consumer personal data to the state, etc.

Approved by the Governor on May 17, 2023

The bill amends statutory language by:

 Prohibiting district school boards from requiring certain students to take course before taking high school equivalency examination unless student failed to earn passing score on specified practice test.

HB 267 - Relating to Telehealth Practice Standards





Pay Compression Agency Discretionary Pay Plan - \$7M

Effective October 1, 2023, funds are provided for agencies to grant special pay adjustments to address pay plan compression, recruitment, and retention issues for eligible employees or cohorts of employees after the statewide pay adjustment.



Targeted Retention — \$3.4M

Continue implementing a targeted retention pay plan for the Correctional Officer series, Correctional Probation Officer series, and the Inspector series. Staff will be eligible to receive this increase based on continuous years of service with the department on June 30, 2023. The maximum amount an officer can receive is \$2,500 as follows: \$1000 - 2 YRs continuous employment mark, \$500 - 5YRs continuous employment mark, and \$1000 - 8 YRs continuous employment mark.
