RULE NO.: 33-404.201

RULE TITLE: Operation, Administration, and Designation of Corrections Mental Health Treatment Facilities

PURPOSE AND EFFECT: The purpose and effect of the amendment is to add Suwannee Correctional Institution as an institution at which the Assistant Secretary for Health Services has designated a mental health treatment facility for male inmates.
